There has always been struggle for funds too. But I always kept in mind what Dhirubhai Ambani once said – "If you have a solid business plan, funds will never be difficult". Then came phases of many challenges when the existence of the company became difficult. But as I said before, when your clients and associates trust you and support you, no challenge is insurmountable.

My motto throughout has been "Perseverance is the very hinge of all virtues." This I copied in my diary from what my teacher wrote on the blackboard and this has stayed with me all along. To this day, I believe in that and persevere for any objectives that I set.

There are many theories in management. One theory is to focus only on one business where you have complete mastery. The other one is slightly broader. Bajaj Auto believes that making motor cycles is their area of excellence and they stopped making scooters. Tata Motors believes that moving people and materials from one point to the other is the expertise that they have. I believe in the latter theory. Display is our expertise, whether it is in the field of exhibitions or any allied businesses. Broad basing helped us find new pastures.

Meroform is gearing up to overcome the challenges posed by Covid19. COVID is a circuit breaker and Black Swan. It is too early for a prophecy as to what will happen when the pandemic is over. Sometimes, I think a bit philosophically, that world will be a better place having experienced the humbling phase we are going through now. I also believe that post COVID world will be a much more efficient place with more technology interventions.

The challenges and opportunities come from technology. The shift from physical to virtual is an emerging challenge. The setback the virtual is facing is temporary. It will become better and better as time goes along and become a challenge to wood and aluminium. The opportunity also lies in the same sphere. We have a wonderful opportunity to migrate to a better and eventually profitable phase. Right now an Indian exhibition is visited by a million at the max. 




Kumbh Mela 2021 at Haridwar & Rishikesh: Temporary Shelters construction made by RMB Event Management, Mumbai, India


















GST UPDATES

Under GST, every registered person having aggregate turnover exceeding Rs. 50 cr in FY 2020-21 is required to



comply with E-invoice provisions. Aggregate turnover includes the sale of taxable / exempted / exports of goods or services, sale to branches with different GST registration but the same PAN.

Provisions of E-invoice are summarised as-

- 1. E-invoice is required for the supply of both-goods and services.
- 2. E-invoice provisions are required to be complied with only by the registered person. Those who are not registered in GST are not required to comply with E-invoice provisions
- 3. E-invoice provisions are required to comply while exporting goods or services outside India or while supplying goods or services to units located in SEZ area

- **4.** E-invoice provisions are **not required** to be complied with by the units located in SEZ.
- **5.** E-invoice provisions are applicable only if goods or services are supplied to a registered person. If the customer to whom goods or services are supplied are not registered in GST, i.e.

B2C supply, then **E-invoice provisions** are not applicable.

6. While supplying goods, the provisions of E-invoice are required to be complied with before or at the time of despatch of goods. Goods cannot be supplied until the provisions of the Einvoice are complied with.





- 7. If the business enterprise supplies both taxable and exempted goods, then E-invoice provisions are required to be complied with only in case of taxable supply. No compliance is required when exempted goods are supplied.
- **8.** E-invoice provisions are required to be followed while issuing tax invoices or revised invoices. The provisions are **not** applicable while generating tax invoice under RCM for inward supply, Debit note, Credit note, Delivery Challan.
- 9. Even after compliance of E-invoice provisions, business enterprises are required to generate E-way bill, wherever applicable.
- **10.** If the provisions of the E-invoice are applicable but have not been complied with, then both buyer and supplier are liable to be penalized.
